Reminder, waivers are submitted annually, however if you add a **NEW** boat captain or angler a waiver will need to be submitted. Waivers are emailed to boat captains, anglers and anglers parents/guardian after coaches register them on [abnhs.org](http://abnhs.org) website under coach's login.*

**OFFICIAL PRACTICE:** Official practice begins Monday (April 20, 2026) at safe daylight and goes thru Friday (April 24, 2026), which means you can **only practice with anglers & Boat Captains** that are competing in this tournament and **no outside information from non-participants**. Must be off the water by 5:00pm, Friday, April 24, 2026.

#### TOURNAMENT WATERS OFF-LIMITS

Off-limits will be announced at the tournament briefing via Facebook Live-Stream. Any waters closed to Public Fishing will be closed to Tournament Anglers.

#### FISHING LICENSE

An Alabama Fishing License is required to fish in the tournament if Angler is 16 and over. **All High School Anglers MUST have a vessel license per the new B.A.S.S.
